Rules

Camping Den Goeiendonk

Best guest,

Camping Den Goeiendonk does everything to make it as pleasant as possible for you and your fellow guests during your stay. We have made a number of rules for this that you can find in these internal regulations. Because of our membership at Vekabo we also use the "Vekabo conditions tourist places". These internal regulations are in addition to these conditions. We assume that every guest is aware of these rules and will comply with them.

General

The owner of Camping Den Goeiendonk is not liable for damage and / or injury caused as a result of the stay on the site, as well as damage suffered by the use of the facilities (facilities) present on the site. Camping Den Goeiendonk and its owner are also not liable for damage claims arising from noise or odour nuisance and any external calamity, as well as the terrain conditions as a result of weather influences. Furthermore, no liability is accepted for the inoperability and / or out of use of the existing facilities and / or facilities. Everyone stays entirely at their own risk.

Camping Den Goeiendonk and its staff are at all times entitled to deny unauthorized persons and / or people who misbehave access to the site.

• In all cases where these regulations or the "Vekabo conditions do not provide tourist places" the owner of Camping Den Goeiendonkdecides.

Kampeerplek

- The camping equipment must be placed behind the gravel. With the exception of tents.
- It is not allowed to attach things in the ground at the rear of the camping spot because of.m. the existing pipes. Therefore, keep about 1 meter away from the back with fasteners.
- Between 22.30h and 8.00h there is a night's sleep at our campsite. It is then forbidden to play music or make noise on the campsite.
- It is not allowed to stay with more than 5 people on 1 camping spot.
- Groups larger than 8 people are only allowed in consultation. (incl. children)
- Vacancy is only permitted after consultation and may not exceed 25% of the camping period with a maximum of 5 days. In the high season (Ascension Day, Pentecost, July, August) there is no vacancy rate.
- Side tents have a point or dome model and have a ground area of up to 4m2.
- As a ground cover, root cloth or other plastic covering material are not allowed. Only ground cover with an open structure should be used to prevent suffocation of the grass.
- Open fire or fire pits are not allowed on the camping spot. Barbecuing on the camping pitch is allowed with gasand electrical appliances or coals (min 50 cm from the ground.)
- Upon departure you must leave your camping spot clean.

- In case of a reservation of a camping spot, the general terms and conditions Vekabo apply. Where it does not provide, these internal regulations apply.
- A camping spot is not a parking space. You must park your car in our car park, with the exception of arrival and departure.
- Campers or caravans with a weight of more than 3500kg or a length of more than 7.5 meters are only allowed in consultation.
- Campers or caravans with 2 axles are not allowed.

Arrival and departure

- Arrival is possible from 13.30h, arriving earlier is only possible in consultation.
- You must have left the place before 12.00h due to.m. preparatory work for the next guest.
- If you arrive on Sunday, it may be that no one is present. We can be reached by telephone.

Afval

- Household waste can be deposited in the container at the back of the sanitary building. Please only deposit closed waste bags in the container.
- The dumping of bulky waste is not permitted.

Pets

- There is a maximum of 2 pets per pitch.
- Pets must be kept on a leash.
- The campsite and our surrounding areas are not an outlet, there is sufficient outlet in the vicinity. If your pet accidentally does his need on the premises, you must clean this up yourself.
- Pets may not be a nuisance to other camping guests.

Visit

- Visitors will be charged for stays longer than 1 hour. If your visit stays later than 22.30h or if they stay overnight, this counts as an extra night.
- Large groups of visitors of more than 4 people are only allowed in consultation.
